I, Chester Martyn Hudson, of Heath Close, Old Heathfield Road, Heathfield, East Sussex, do solemnly and sincerely declare as follows:-

I visited the offices of the Wealden District Council at Vicarage Lane, Hailsham, Sussex, on or around 23rd. March 2016. The purpose of my visit was to view file WD/1987/ 3194/F in the expectation of finding a declaration of interest in the minutes of the Area Plans (South) meeting that determined this application on or around 8th. December 1987.

I was given a Planning History sheet by a male officer. From this sheet I selected WD/1987/ 3194/F and the officer brought me five (micro) fiches all of which had yellow headers. I then examined these under a microfiche reader.

I immediately noticed on fiche 1 or 2 a letter sent in by Ian M. Kay, of High Trees, Horsted Keynes. He declared an interest in application WD/1987/ 3194/F. The applicant, Denis Best, was his father in law. The letter was dated c. 17th. October 1987.

Adjacent to this letter was a formal acknowledgement of receipt of this declaration on Wealden headed notepaper from an officer, Mr. Tomlinson.

I noted the detail "IMK Tomlinson 17.10.1987" on the back of the planning history sheet (Exhibit 1) and asked the officer to email me the letter of declaration, the response, and a letter submitted by David Randall Sinnatt.

Subsequently I received the Randall Sinnatt letter by email but I did not receive either the declaration or the acknowledgement.

I revisited Wealden's offices again on 4th April 2016. The purpose of my visit was to obtain from file WD/1987/3194/F a copy of the letter of declaration and acknowledgement. Ms. J. Pidgeon kindly supplied the fiches, however the headers were all green, not yellow.

I scanned through the green headed WD/19873194/F. Nowhere could I find either the declaration of interest letter I was seeking or the letter of acknowledgement written by Mr. Tomlinson. Nowhere could I find a minute relating to any declaration of interest. I did see and ask for an email copy of a letter from Vic Scarpa detailing the protocol relating to S.27 notices. I manually scheduled the names and addresses of the objectors to 3194/F (Exhibit 2), returned the fiches, and asked Ms. Pidgeon about the fiches with yellow headers. She supposed that they might have originated from building control.

Later that day I noted my recollection of both my visits, and drove home, having called on an individual who attended the meeting that determined application WD/1987/3194/F. That individual recalled the disinterest of the local ward member Mr. Pragnall at the meeting and a number of challenges that were silenced. When the silenced challenge was finally made it was to enquire whether it was correct for Assistant District Planning Officer Ian Kay to commentate on his own father in law's application.

Once sworn, this affidavit will be sent to the District Solicitor at Wealden District Council, Vicarage Lane, Hailsham, BN27 2AX under recorded delivery docket KF 7485 9793 5GB.

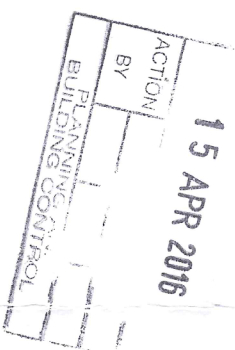

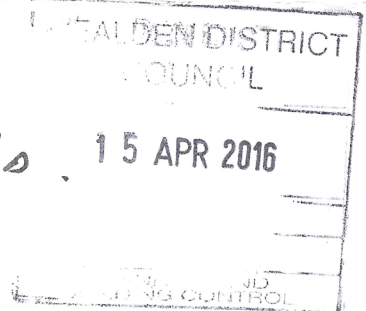

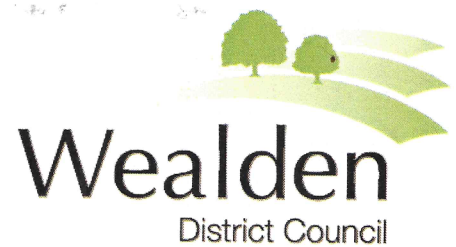
